Note:- 1. The Internal Assessment Tests will be conducted on the last day of Personal Contact Programme(PCP) as per scheme of Examination. The test will be a part of classroom. The Registration of the students will be done from 9.00 a.m. onwards on 15.04.2025.

2. Since the PCP's are conducted for the benefit of the CDOE students and as mentioned in the Prospectus 50% attendance in the PCP is COMPULSORY to become eligible to appear in the University examination, they are advised to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case. No change of PCP center/batch will be entertained in any case.

3. The candidates are also advised to pay the balance fee/2<sup>nd</sup> Installment fee and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examination failing which they will not be allowed to appear in the University examinations.

4. A written test on account of Internal Assessment as per scheme of examination during Last day of PCP as guidelines issued by Centre for Distance and Online Education.

NOTE: In Case any candidate does not complete the eligibility condition of the course even after attend the PCP his/her candidature will be stand Cancelled/Not eligible. He/She will be allowed to attend the PCP Provisionally

In view of this, the candidates are advised to attend the PCP, though submission of written assignment is not compulsory, the students in their own interest are also advised to submit written assignments on topics concerning their courses for evaluation by the teacher.
